The end-to-end service provided to clients can extract any meta-data elements, legal provisions, term and conditions, and even obligations from these contracts (attributes), and organize them into a structured database for triggering and for performing smart queries. Typically uploaded into a Contract Lifecycle System, this extracted data is used to increase the adoption and effectiveness of the system, recover revenue (e.g. extract and
